I, _____ (the "**Parent or Guardian of Minor Participant**"), signing on behalf of _____ (the "**Minor Participant**"), sign on the ____ day of _____, 20__ this RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT in favour of Nat's Adventure Travels Ltd., and all related or associated companies and their respective owners, directors, officers, employees, agents, representatives, instructors, assistant instructors, guides, contractors, leaders, members, trip leaders, volunteers, independent contractors, subcontractors, sponsors, successors and assigns, participants and organizations participating in or connected with the Adventure Activities (defined below) (hereinafter collectively referred to as the "**Releasees**").

In this Release Agreement, the term "**Adventure Activities**" shall include all activities, events, or services provided, arranged, organized, conducted, instructed, sponsored, or authorized by the Releasees, including but not limited to: hiking, backpacking, trekking, winter hiking, camping, Nordic skiing, orienteering, snowshoeing, walking/running off payment, walking/running on pavement, walking/running/hiking on steep, uneven, icy, and/or mountainous terrain (on or off trail), travel in conveyances including but not limited to cars, vans, mini-vans, buses, mini-buses, coaches, coach buses, 4x4 vehicles, bikes, and/or all-terrain vehicles in urban, rural, and/or remote environments, including orientation and instructional sessions or classes, transportation, loading and unloading of vehicles, carrying of equipment, accommodation (including camping or overnight stays in the outdoors), food and beverage, and water supply, and all recreational and skill development activities either provided by or arranged by the Releasees.

ACKNOWLEDGEMENT – SAFETY

I acknowledge that I have been advised the Minor Participant must, and will, wear the appropriate safety or protective equipment while participating in Adventure Activities. I am aware that the physical exertion required by Adventure Activities and forces exerted on the body can activate or aggravate pre-existing injuries, conditions, symptoms, or congenital defects. I have been advised to seek medical advice if I know or suspect that the Minor Participant's physical condition may be incompatible with the Adventure Activities.

I acknowledge that the Minor Participant will not be under the influence of drugs and/or alcohol while participating in the Adventure Activities.

DESCRIPTION AND ASSUMPTION OF RISKS

Initial _____

There are many potential **RISKS, DANGERS** and **HAZARDS** associated with Adventure Activities including the **RISK OF SEVERE INJURY OR DEATH.**

The terrain used for Adventure Activities may be uncontrolled, unmarked, not inspected, and involves many risks, dangers and hazards. Risks, dangers and hazards associated with Adventure Activities may be caused by natural forces or by persons travelling through the terrain and may include, **but are not limited to:**

Accidents which occur during transportation to and from the location; falls, trips and slips; extreme variation in terrain, including hidden or exposed rocks, boulders, ice, cornices, crevasses, cliffs, logs, stumps, roots, forest deadfall, tree wells, trees and other objects; falling trees; still and moving water; lakes, streams, creeks and rivers, including crossings; cold water immersion; entrapment by trees, logs, rocks or equipment; drowning; limited visibility; variable, adverse, severe or rapidly changing weather with little or no warning including storms, rain, snow, blizzard, hail, high winds, lightning, and tornado; dangerous and unpredictable water conditions, including waves, currents, rapids, white water and waterfalls; impact or collision with rocks, trees, logs, deadfall, other participants, or other equipment; hypothermia; hyperthermia; frostbite; holes and depressions on or below the snow surface; variable and difficult snow conditions; road banks, fences, and other man-made structures; snow immersion; loss of balance or control and falls, particularly on steep, slippery or difficult terrain; difficulty or inability to control one's speed and direction; errors of judgment; errors in navigation; lack of preparation; inadequate, inappropriate, improperly prepared or adjusted equipment; equipment failure, malfunction or loss; loss or damage to personal property; failure to act safely or within one's ability or within a designated area; impact or collision with means of conveyance (including without limitation cars, 4x4 vehicles, bikes, and/or all-terrain vehicles), other persons or objects; physical damage to personal conveyances; encounters with domestic or wild animals; animal/insect bites; poisonous vegetation; becoming lost, going off route or becoming separated from one's party; my own actions or those of others; remote locations with unreliable or dangerous travel/driving conditions; and travel over poor roads.

Communication in the terrain where Adventure Activities occur may be difficult, and it may be difficult or impossible to communicate with the outside from within such areas, and in the event of an accident, rescue and medical treatment may not be readily available or accessible.

I am aware that participation in Adventure Activities also **MAY INCLUDE RISKS INCLUDING NEGLIGENCE ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF PARTICIPATING IN ADVENTURE ACTIVITIES. I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE AND LOSS RESULTING THEREFROM.**

I am aware that Nat's Adventure Travels Ltd. does not carry any accidental death, dismemberment, life, disability or medical expense on my behalf, and it is my own responsibility to obtain such additional insurance coverage, if needed, for my participation in Adventure Activities.

In consideration of the RELEASEES agreeing to my participation in Adventure Activities and for other good and valuable consideration, I do hereby freely, voluntarily, and without duress agree as follows:

1. **TO WAIVE ANY AND ALL CLAIMS** that I, or the Minor Participant, have or may in the future have against the **RELEASEES AND TO RELEASE THE RELEASEES** from any and all liability for any loss, damage, expense or injury, including death, that I may suffer or that my next of kin may suffer, as a result of my participation in Adventure Activities, **DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT THE MINOR PARTICIPANT FROM THE RISKS, DANGERS AND HAZARDS OF PARTICIPATING IN ADVENTURE ACTIVITIES, INCLUDING THE RISKS REFERRED TO ABOVE.**
2. I agree TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any property damage or personal injury to any third party resulting from the Minor Participant's participation in Adventure Activities.
3. I agree TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all expenses incurred by the Releasees, including legal fees and/or settlement payments and/or Court or Tribunal awards, as a result of legal or administrative actions brought by myself or the Minor Participant.
4. I acknowledge that it is my responsibility to advise the Releasees of any medical and/or health concerns which may affect the participation of the Minor Participant in the Adventure Activities.
5. Should the Minor Participant require first aid or emergency medical treatment as a result of accident, illness or any medical issue while participating in Adventure Activities, I consent to such treatment as deemed necessary by the Releasees.
6. Should the Minor Participant require non-scheduled or emergency evacuation, rescue, first aid or medical treatment, I agree that I will bear all costs and expenses associated with such non-scheduled or emergency evacuation, rescue, first aid or medical treatment, and these costs and expenses will not be covered by the Releasees.
7. I agree TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability on account of any first aid, treatment or services rendered in connection with the participation by the Minor Participant in Adventure Activities.
8. I understand that the Releasees do not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to any disability, accident, liability or medical insurance or compensation in the event the Minor Participant becomes injured or causes personal injury or property damage to any third party while participating in the Adventure Activities.
9. I certify that no qualified medical professional has advised the Minor Participant to **not** participate in Adventure Activities.
10. I understand that the Releasees may be using or recommending the services of certain hotels, organizers, facilities or other agencies not directly controlled by the Releasees (in this paragraph, a "**Third Party**"). I further understand that the Releasees accepts no responsibility for any acts or omissions of, or for any breach of contract, misrepresentation, negligence or error of such Third Parties, with respect to all matters in connection with the Adventure Activities. I agree that I will not hold the Releasees responsible for such any such cancellation, curtailment, or material changes to the Adventure Activities by any Third Party, and in particular, I agree to release and hold harmless the Releasees from, and will not bring legal action against it for, any claims, demands, expenses, costs (including legal costs), suits, debts, liabilities and causes of action which may arise out of or be connected to any act or omission by any Third Party.
11. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity.

12. This Release Agreement and any rights, duties and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of Alberta and no other jurisdiction.
13. Any litigation involving the parties to this Release Agreement shall be brought solely within the Province of Alberta and shall be within the exclusive jurisdiction of the Courts of the Province of Alberta.

If any portion of this agreement shall be held to be invalid or unenforceable, such provision shall be stricken and the remainder of the agreement shall remain in full force and effect to accomplish the intent and purpose of the parties. The parties agree to negotiate the severed provision to bring it within the applicable legal requirements to the extent possible.

In entering into this Release Agreement, I am not relying on any oral or written representations or statements made by the Releasees with respect to the safety of participating in Adventure Activities, other than what is set forth in this Release Agreement.

PHOTO/VIDEO RELEASE – I understand that during Adventure Activities the Minor Participant may be photographed or videotaped and I consent to such photographs and/or video taken of the Minor Participant being used for personal, advertising, promotional or marketing purposes.

I confirm that I have read and understand this Release Agreement and by signing it voluntarily I am agreeing to abide by these terms. I am aware that by signing this Release Agreement I am waiving certain legal rights which I or my heirs, executors, administrators, assigns, and representatives may have against the Releasees.
